### **Objectives of the Practice**

The college believes in the saying “

अन्नदानम् परम् दानम्  
विद्या दानम् अतः परः!  
अन्नेन क्षिणकः तृप्तिः

[Serving food is the best of all services  
But educating is of even higher service  
Food quenches the hunger temporarily  
Whereas education is eternal]

The main objective of this programme is to serve lunch to needy and hungry students of the college. Many students of the college are from rural areas and from very poor background. They attend the classes from morning till late afternoon on empty stomach. This results in attention deficit and low academic performance. To attend such issues the college began this noble practice-a tradition of this land serving food to needy- in the year 2010.

The college is the benevolence of His Holiness **Sri Sri Sri Shivakumara Mahaswamigalu**, the founder of this institution, a part of SSES. He is the great practitioner of serving “food, shelter and education” to needy and poor students of this state. He is referred as “Trividha Dasohi”- practitioner of three great services - serving food, shelter and education. Around 10,000 students are the beneficiaries of this noble thought.

Inspired by this noble practice of His Holiness the Alumni association with the active participation of the faculty and local philanthropists initiated the programme. It is one of the noble Practices of the college in force for -----years

In the beginning of the academic year, applications are invited from the needy students. Applications are scrutinized, shortlisted and are interviewed to ascertain the genuineness. Separate ID cards are issued to the selected students. They are given the roll numbers and attendance is maintained to check the misuse of the facility.

Under the chairmanship of the principal a committee is formed comprising of a coordinator, treasurer and some teachers as members for the success of the practice. Members of the committee supervise the service. Long absentees are counseled for better use of the practice. Academic progress of the beneficiaries is monitored. The quality of food is ensured by entrusting the job of preparation and serving to a good caterer.

In the beginning the programme faced problem of no student availing the benefit. The reason for this was that students did not like to be identified as poor. But once they were convinced about its benefits, they slowly enrolled and began to reap its advantages. The programme was flagged off by liberal contribution of teachers of the College in the beginning.

In recent years the programme is a success thanks to the contribution of Alumni Association and benevolent local donors.

The PEER committee of 2<sup>nd</sup> cycle appreciated the practice of mid day meal for poor students and recommended to register the committee to bring in transparency and accountability. Accordingly a trust was registered under the title “**Nitya Dasoha trust**” vide reg No **MK-4-00547-2016-17 CD NO TMK 0738** dated ...**05-12-2016.....**

**12. ACCOUNTS**

**13. BANK ACCOUNTS**

All Bank accounts shall be opened in the name of the trust and shall be operated by The President and Treasurer of the Trust jointly.


**14. DISTRIBUTION OF PROFITS**

Further no amendment shall be carried out without the prior approval of the Chief Commissioner of Income Tax.

The Powers vested in the Managing Committee shall be exercised according to the decision of the majority of the members of the Board of Trustees and the decision of the President shall be final and binding on the Managing Committee.

If for reason that the trustees are equally divided on any subject matter and decision can not be arrived at, the President shall have one Casting Vote as President, in addition to his vote as Trustee, and decision shall be arrived at accordingly.

**11. DUTIES OF SECRETARY**

- a) To manage and conduct day to day operations of the trust.
- b) To maintain the books of accounts and get the accounts audited and file the same with the concerned authorities.
- c) To record and maintain the minutes of the meeting of the board and furnish the same to the concerned authorities.

The duration of the office bearers is five years.

All the above persons shall be liable for retirement and new office bearers shall be elected by the Board of Trustees for another period of five years. The persons retiring are also eligible for re election.

Managing Committee shall work towards achievements of objects of the trust under the general supervision and delegated powers of the Board of Trustees.

Terms of the trustees:

01. Term of the trustees - Till they attain the age of 70 years.

02. Appointment of new trustees - The board of trustees shall have the power to appoint new trustees as and when the vacancy arises.

### 8. POWERS OF THE MANAGING COMMITTEE.

In execution of this trust and with a view to carry out the objects of this trust and to augment its funds and to administer them in discharge of their duties, the Managing Committee shall have the following powers.

- a. To carry on the objects of the trust as stated in clause (4) of the deed.
- b. To receive any money or other assets in any shape or form and when given by the "Author of the Trust" or any other person/s, Trust, Government Agencies, Institutions, Society, etc., as gift or donation.
- c. To collect funds by donations, grants, presents or contributions and other offerings from within the country / outside the country with requisite authorities.
- d. To invest the Trust Funds in such securities and in such manners as may be prescribed under the provisions of Section 13(1) r.w.s 11(5) of the Income Tax Act, 1961 for the time being in force and as amended from time to time.






